Dear President Kuncl:

I am writing to inform you that on June 24, 2015, the Committee on Accreditation, on behalf of the Commission on Teacher Credentialing, assigned the status of **Accreditation with Stipulations** to the University of Redlands and all of its credential programs.

Following are the stipulations to be addressed in a focused revisit to take place within one year:

- The University of Redlands must provide evidence that a comprehensive and unit wide assessment and evaluation system that addresses all credential programs is implemented and guides program improvement.
- The University of Redlands is to show evidence that communication systematically occurs to: a) discuss and clarify course content in the course sequence of each program, b) assure program cohesion and c) discuss candidate competence measures and data as well as data to inform program improvement.
- The University of Redlands is to provide evidence that faculty have been assigned to teach courses based on their qualifications and experience.

Furthermore, the University of Redlands is to include in its next Biennial Report for the Preliminary and Clear Administrative Services credential programs the numbers of current program candidates and completers, clarification of key assessments, information about the alignment of the assessments with program standards, and aggregate data on candidate and completer competence, fieldwork and program effectiveness.

On the basis of this decision, the institution is authorized to recommend candidates for the following credentials:

Preliminary Multiple Subject Credential
Multiple Subject Intern

Single Subject Credential
Preliminary Single Subject Credential
Single Subject Intern

Education Specialist Credentials
Preliminary Mild/Moderate Disabilities
Mild/Moderate Disabilities Intern

Pupil Personnel Services
School Counseling

Administrative Services
Preliminary Administrative Services
Preliminary Administrative Services Intern
Clear Administrative Services

In addition:

- The institution's response to the preconditions is accepted.
- University of Redlands is permitted to propose new credential programs for approval by the Committee on Accreditation.
- University of Redlands continues in its assigned cohort on the schedule of accreditation activities, subject to the continuation of the present schedule of accreditation activities by the Commission on Teacher Credentialing.
